## MEMBERSHIP APPLICATION INFORMATION

All artwork must be the original hand produced work of the artist applying, and work to be juried must be representative of the work to be displayed in the gallery. Items not acceptable include kit work, manufactured items, molded ceramics, and dried flower arrangements.

After jury committee approval potential new members will need to sign the membership contract. All members will pay a one-time buy-in of \$300.00. Full payment can be made or installments arranged at contract signing. Please note that we can accept Master Card or Visa for membership buy-in. Membership buy-in is nonrefundable.

Members are responsible to also pay a monthly 'rent' payment of \$35.00. We pay only 25% commission on work sold at the Gallery, and get an Artist's discount of 10% on anything we purchase at the Gallery. All the Members must work assigned days at the Gallery and must serve on a committee such as marketing, operations, display, membership/jury or finance. Artists are expected to attend when special events are scheduled at the Gallery.

## JURYING INFORMATION

1. Jury will meet once a month.
2. Jury application forms will be available at the Riverside Artists Gallery.
3. Applications can be sent or brought in to the Gallery and must be accompanied with a \$10.00 application fee. (non-refundable).
4. Applicants will be contacted to schedule a jury appointment and interview. On the day of the appointment, please bring completed application form and 4 – 8 pieces of work for jurying.
5. Qualified members in each media may be called on by the Chairperson to assist the jury committee. All work will be judged on:
  - a. Originality
  - b. Uniqueness of design
  - c. Quality of workmanship
  - d. Ability to be displayed effectively,
  - e. Must not duplicate current work in the store.

Also if a member wants to display product different from their current line, they must jury the new products. Riverside Artists Gallery reserves the right to return any work that we deem unsuitable.
